At the outset, the Chairperson IQAC & Hon. Vice Chancellor welcomed all the members of the IQAC. Then the following agenda items were taken up for discussion.

Agenda Item no. 1

Confirmation of the Minutes of the Fourth Meeting of IQAC held on 18 July 2019, and ATR thereof.

The IQAC resolved to confirm the Minutes of the Fourth IQAC Meeting held on 18th July 2019.

Agenda Item no. 2

Applying for NAAC Accreditation and Assessment under Dual Mode University Category.

After a detailed discussion the IQAC resolved that the University should apply to the NAAC for the assessment and accreditation of MANUU under dual mode university category before 31 January 2020 for raising its CGPA to 3.26 and above.

The Chairperson IQAC and Hon. Vice Chancellor, MANUU directed IQAC to constitute committees first, for carrying out all NAAC related assessment and accreditation work.

Therefore, the IQAC resolved that the committee for each Criterion of Quality Indicator Framework(QIF) shall be constituted separately. The primary job of each Committee shall be to seek data from the departments concerned, furnish the information sought in the assigned Criterion of QIF, and prepare the report of the Criterion thereof.

An ICT committee shall be constituted to assist all committees.

All the members of teaching faculty and non-teaching staff of MANUU shall necessarily provide help when approached by any Committee constituted to carry through accreditation related work.

All the members of teaching faculty and non-teaching staff must treat NAAC accreditation work on priority.

All the members of IQAC shall be the members of Core Advisory Committee (CAC) who should meet regularly till the assessment and accreditation work is fully accomplished.

The IQAC resolved to approve the 2018-2019 AQAR in the new format, which is required to be submitted online to NAAC.
