Item No. 4:

Modification of the topics of the research work of the M.Phil. and Ph.D. scholars of previous batches.

The Board resolved to approve the specific topics of M.Phil. and Ph.D. research scholars of previous batches.

In case of Mr. Arif Ahammed, (Enrolment No. 1201040201) M.Phil. scholar, his Research Supervisor submitted a letter for modification of the topic without changing his broad area of study. His topic shall now be read as 'Disability and Masculinity in Contemporary Drama: A Study of Mahesh Dattani's Plays'.

The Board approved the same.

Item No. 5:

List of M.Phil. and Ph.D. recipients.

The Board noted the matter.

Item No. 6:

Proposed paper for Academic Reading and Writing.

The Board discussed that proposed paper and appreciated the effort of the members of the faculty who devised it. However, the Board suggested that the paper requires more works to be included in the suggested reading list; and in respect of the 'evaluation pattern' it was suggested that the evaluation policy of the University must be adopted. The matter shall be further discussed in the School Board Meeting.

Item No. 7:

Proposed paper for Urdu Literature in Translation for M.A. English students (on Executive Council's Direction).

The Board discussed the paper. It suggested chronological ordering of the paper with some inclusions in respect of 'Drama'. It suggested further strengthening of the paper. Professor Anisur Rahman and Professor Mohammed Zafaruddin offered their help in making some improvements and modifications in the paper.

Item No. 8:

Proficiency Course in English (as a general certificate course) and English as Credit Course for all PG programmes.

The Board resolved to form a two-man committee comprising of Mr. S. Omprakash and Mr. G. Govindaiah to improve the course design and strengthen it with appropriate material.

Item No. 9:

Extension of the List of Panel of Examiners for M.Phil. and Ph.D. Programmes.

The Board resolved to approve the Panel of Examiners, and included the names of Examiners proposed by Mr. S. Omprakash.

Item No. 10:

Consideration of the requests of Ph.D. candidates to grant UGC non-JRF fellowship during the eligible extension period.

The Board recommended the extension of the grant to the scholars.








The Meeting ended with the Board members extending their thanks to the Chair.
