The matters under process as per decision of BoS held on 18.6.08 were taken up for Action Taken Report and discussion.

a) The course on Maulana Azad Studies introduction last year is in operation and has been consistently successful and popular.

 b) Dept. of English had proposed (as per decision of the BoS) that the Proficiency Course in English be converted into a Regular credited course of 100 marks for one semester in Regular MA Class. This proposal was discussed at length at the Academic Council held on 20.08.09. The item was not passed because of the objection of one member, though, the efficacy of the proposal was generally agreed upon.

Department of English proposes to take up this matter at the level of School Board of Stly and will refresh the project to be taken up as agenda item in the next AC.

Members endorsed the proposal.

c) The revised syllabus of M.Phil was presented with additions/ alterations as per the advice of last BOS(18.06.08)

The revised syllabus was approved

- d) The BoS had proposed that 'Urdu Knowing' should be adopted as one of the criteria for admission to MA/M.Phil/PhD in English.
- e) The chairman / HOD Dept. of English informed the members that the priority list will be finalized and included in the prospectus of 2010-11.
- The external members commented on the need to build up a Departmental library and also acquire software like EPSCO and DELNET for accessing on line journals and study materials. The chairman informed members that the Departmental library had been set up and was being continually supplemented. Dr. Shugufta Shaheen, Asst. Professor, Dept. of English was in charge of the same.
- Chairperson BoS further informed the members that the Guidelines for M.Phil /PhD (Regular and Part time) were now passed in the Academic Council. The formal orders were awaited. Now clarity now about the rules and regulation governing the Regular programmes is available in the new regulations.

After this discussion the minutes were confirmed and Agenda items were taken up.

- b) Following students of M.Phil (batches 07 & 08) are unable complete their M.Phil programme because their Part – I is still held up BoS decided that a popportunity should be provided for them to complete their programme. The guidelines for M.Phil also provided for Part – I exam of M.Phil to be held twice a year. The backlog cases should be allowed to take Part – I exam alongwith the present batch in Jan-Feb, 2010.

## Any other Item:

- a) Entrance for admission into MA was discussed and approved. Dept. of English will take up the matter at the standing Committee of Academic Council it was suggested that 70:30 ration would be followed I the Entrance Test for OT testing and descriptive type. to be operation from session 2010-11.
- b) Internal Assessment pattern would be modified to
  - Two tests instead of Assignments 15marks
  - (ii) Seminar / presentation 15 marks
- c) The Project of weekly Seminar would be set in motion w.e.f. the even semester 2010.
- d) Dept, of English would be going in for Special Assistance Programme (SAP) in the ensuing months. Proposals would be worked out. BoS suggested Interdisciplinary approach to Language and Literature studies with focus on English – Urdu literatures so as to have an orientation to Departmental agenda as well as the MANUU mandate. Once the preliminary files are readied it was proposed that Prof. Siddiq Ali would be requested to sit with colleagues in Dept. of English for finetuning the proposals.
