3.2. Request for extension time.

Mr. Faiyaz Alam, Ph.D Scholar, Enrolment No. A161028 has requested to give more time to complete the research work.

As per the request letter received from the Mr. Faiyaz Alam through his Research Supervisor informed that his research work is almost done. The draft of his thesis is about to complete and due to COVID-19 and health issues he could not finish his research work. In this letter he has not mentioned how many months he wants extension.

As per the Public Notice issued by the UGC date 3.12.2020 mentioned that extension of date for submission of thesis for terminal M.Phil/Ph.D students, who ere supposed to submit their thesis by 31.12.2020, may be granted by the Universities ie. till 30.06.2021.

The DRC members discussed the matter. The DRC resolved and approved the request for extension till 30.06.2021.

Item No.4 Cancellation of Ph.D. Admission

4.1 Ms. Nafeesunnisa, Ph.D. Research Scholar with enrolment No. A162312 (date of admission 28.03.2013) under the supervision of Prof. H. Khatija Begum, Professor (Rtd) has selected for the post of TGT Science in Telangana Minorities Residential School at Nagaram in Nizamabad District. A letter has been sent to the concerned scholar to submit the NOC from the employer to continue the Ph.D. Till date no reply has been received. Furthermore, as per record the scholar has not attended RAC meetings since July,2019.

"As per Clause 5.18 A full time research scholar shall not accept employment during the tenure of the Ph.D program and As per Clause 19.3.2 Where a research scholar discontinues his/her research, or when he/she accepts any appointment/employment without the written consent of the Dean of the school concerned". The scholar has not obtain written permission from the Dean, School of Education and Training, to join the duty/ employment

The DRC members discussed the matter and approved for cancellation of Ph.D Admission.

Mr. P. Hifazathulla, Ph.D Scholar (part-time) bearing Roll No.132010001 of 2013 4.2 batch submitted his application for re-admission through email to the Directorate of Admission. As per the Ph.D Regulations he has to complete his Ph.D work in six years ie. April,2019. But he has neither reported to the Department since long or seek any extension for his research work.

As per the directions, Mr. P. Hifazathulla cannot be considered for re-admission as his registration time is over.



4.3 Mr. Fazalur Rahman, Ph.D scholar(part-time) with Roll No. 01160101001 was enrolled in Ph.D. programme in 2011. As per the Ph.D. regulations of MANUU, the maximum duration for the Ph.D. program is 6 years from the date of registration/admission. But he has neither reported to the Department since long or seek any extension for his research work.

The DRC members discussed the matter and approved for cancellation of Ph.D Admission.

4.4 Mr. Mohd. Abdul Rahman, Ph.D Scholar bearing enrolment No.A161130 batch 2015 has requested to de-register his Ph.D. Admission and submitted the NOC from the employer to pursue Part-time Ph.D from the Department of Education and Training, MANUU. Further, his Research Supervisor has reported that he has not appeared in RAC meeting since July,2018.

Further, the scholar has not obtain written permission from the Dean, School of Education and Training, to join the duty/ employment. "As per Clause 5.18 A full time research scholar shall not accept any employment during the tenure of the Ph.D program".

- 19.3.1 Where the progress of the research work has been reported to be unsatisfactory in two consecutive Half -yearly progress reports or when two consecutive progress reports are not submitted.
- 19.3.2 Where a research scholar discontinues his/her research, or when he/she accepts any appointment/employment without the written consent of the Dean of the school concerned.

The DRC members discussed the matter and recommend to put the matter before the competent authority for further necessary action.

A letter has been received from **Dr. Sumi V.S**, Assistant Professor, Department of and Training, MANUU discontinuation of Ph.D research work of **Mr. Md. Imtyaz**, Enrolment No. A161031, Ph.D Scholar under her supervision. She informed that **the scholar got employed as Assistant Professor in History by Bihar Government for more that one year**. The scholar has without obtaining written permission from the Dean, School of Education and Training, to join the duty/employment. He not informed the University yet about the employment and not produced NOC for continuing his Ph.D. Earlier he was unable to appear for 3 consecutive meetings. Further, he was allowed to for RAC meeting from the month of July,2019 with special approval from DRC.

Now, the scholar is over again reluctant to appear for RAC meeting for the month of January,2021 after frequent follow-up from the supervisor. Till date no reply has been received from his side. The scholar expressed his unwillingness orally to the supervisor and want to discontinue his Ph.D because of work pressure.

The DRC members discussed the matter and approved for cancellation of Ph.D Admission.

Item No.5 To fix the criteria for allotment of the Research Scholars to the approved Research Supervisors/ Co-Supervisors.

- 1. First preference will be given to those Research Supervisors, who have not been allotted any scholars till date.
- 2. Second preference will be given to those Research Supervisors, who have been functioning as a Co-Supervisor only.
- 3. To calculate seniority, the date of approval as Research Supervisors shall be considered.

Further, as the DRC meeting could not be held regularly due to COVID-19 pandemic situation, those faculty members who had applied for the Ph.D Supervisiorship were considered by the DRC from the date of their eligibility

Item No.6. Allocation of Research Supervisors /Co-Supervisors to the Research Scholars of 2020 batch.

The list of Research Scholars admitted into Ph.D. Programme in the Academic Year 2020 in the Department of Education and Training and CTEs is placed before the DRC for discussion and to allot Research Supervisor and Co-Supervisors.



i. The student should spend at least 3 months with the Co-Supervisor during his /her entire tenure of Research.


