



He informed that the scholar joined employment as Teacher at Primary Level in Bihar Government School located at Begusarai and requested for cancellation of her Ph.D programme.

The DRC members resolved to accept the request and approved for cancellation of Ph.D Admission

6.2 A letter has been received from Dr. Akthar Parveen, Assistant Professor, of Education and Training, MANUU regarding discontinuation of Ph.D research work of Ms. Zulekha Khatoon, Enrolment No. A170599, Ph.D Scholar under her supervision. She informed that the scholar got employed at Bihar State School Board. In her letter she has also mentioned that it may be considered that the scholar has dropped out of the Ph.D programme.

"As per Clause 5.18 A full time research scholar shall not accept any employment during the tenure of the Ph.D program and As per Clause 19.3.2 Where a research. he/she accepts anv discontinues his/her scholar appointment/employment without the written consent of the Dean of the school concerned". The scholar has not obtained written permission from the Dean, School of Education and Training to join the duty/ employment.

The DRC members discussed the matter and approved for cancellation of Ph.D Admission.
