Note: It is proposed to introduce two Non-CGPA courses in MBA semester-III & IV as under as recommended by the BOS, Department of Management & Commerce in its Meeting held on 25.8.2021 and the same is being placed to the School Board through a separate Agenda (item No.4.3) for approval. The total credit shall stand at 106 instead of 102.

- (i) Professional Skills Development-I (2 credits) Semester-III
- (ii) Professional Skills Development-II (2 credits) Semester-IV

The members suggested to invite the Professionals/ Persons from Industry/ Corporate to teach the Professional Skill Development courses. This will provide students the practical skills required at Profession/Industry.

The Board *resolved* to recommend the detailed syllabus as recommended by the Board of Studies, Department of Management and Commerce for the approval of the Academic Council (Annexure-I).

One of the members suggested that the School may constitute a suitable committee with expert members from other institutions to make a plan of action regarding implementation of MOOCs in the context of NEP 2020 recommendations for the programmes under the School. Members were in agreement with the above suggestion.

4.3. Minor updation /corrections in the approved syllabus for MBA, Semester-I & II.

The Board considered and *resolved to recommend* the minor updation /correction in the Ist' & IInd Semester of MBA Syllabus for the approval of the Academic Council (Annexure-II)

4.4. Introduction of two Non-CGPA Courses in MBA (Semester-III & IV)

The Board considered and *resolved to recommend* the following two new Non-CGPA courses in MBA programme to be introduced from 2020-2022 batch onwards with minor modifications, as suggested by the members as in the attached syllabus at **Annexure-III** to the Academic Council for its approval:

- (i) Professional Skills Development-I (2 credits) Semester-III
- (ii) Professional Skills Development-II (2 credits) Semester-IV
