




The DRC members considered her request and approved for Re-registration process.

As per the clause 13.8.2 In the event transfer of Research Supervisor to off-campus/headquarters as the case may be the following shall apply:



Applications have been submitted with a request through their Research Supervisor to permit for Pre-Submission Presentation of their Ph.D work.



## As per MANUU Ph.D Regulations clause:-

- 9.1 The research scholar shall be required to re-register within a period of two and half years failing which his /her admission stands cancelled.
- 9.3 The Ph.D thesis shall be submitted in such duration that the span of initial registration and re-registration done not exceed the total span stipulated for Ph.D program.
- 9.4 The period of de-registration shall not counted for calculating the minimum duration of Ph.D program. De-registration shall be allowed only once in the entire duration of Ph.D program.

The DRC members discussed the matter in the light of MANUU Ph.D Regulations and resolved that her request cannot be considered.
