3.1 Re-Regsitration of Ph.D Admission

Based on the approval of the competent authority, Mr. Md. Raghib Baber, Ph.D. Research Scholar bearing enrolment No. A171075 de-registered his Ph.D to join the employment. Now, he has submitted request for re-registration of his Ph.D programe.

The DRC members considered and approved his request for Re-registration process.

3.2 Allotment of Supervisor of the Ph.D Scholar of Dr. Aftab Ahmad Ansari

A letter has been received from the administration dated 01.06.2022 stating that he has been terminated from lien and relieved from the services of MANUU with effect from 23.02.2021.

As per the Ph.D Regulation of MANUU, Clause 13.8 The research Supervisor/Cosupervisor of the Research Scholar once allotted and approved shall not ordinarily be changed.

13.8.1. In exceptional circumstances like demise/medical reasons/lien/leaving he University/non inevitability of approved Research Supervisor or co-supervisor for a period of more than one year or any other reason with convincing justification for such a change, the Departmental Research Committee/Board of Studies shall alternate eligible faculty member as Research Supervisor of that Research Scholar and forwarded it to the School Board and Academic Council for consideration and approval.

After thorough discussion, DRC resolved to allot Prof. Md. Faiz Ahmad as a Research Supervisor to the Ph.D Scholar (Mr. Syed Taquir Imam) of Dr. Aftab Ahmad Ansari.

3.3 Relaxation in clause - Research Scholar should spend at least three months with Co-Supervisor

A letter received from Mr. Md. Amanullah, Ph.D Research Scholar, Enrollment No. A181447 duly signed by the Research Supervisor and Co-Supervisor has informed that due to inevitable circumstances of COVID-19 pandemic and consequent lockdown, he could not spend three months with Co-Supervisor, Now, he has requested for relaxation in clause - Research Scholar should spend at least three months with Co-Supervisor.

The DRC resolved that, the Research Scholar has to spend three months with Co-Supervisor during the entire Ph.D program and that can be done in different spells or in one spell. Therefore, the request was not considered.

- 12.5 Full -time Ph.D scholar shall compulsory have to put in 75% of attendance in his/her first of the residency.
- 5.18 A full time research scholar shall not accept any employment during the tenure of the Ph.D program and As per Clause 19.3.2 Where a research scholar discontinues his/her research, or when he/she accepts any appointment/employment without the written consent of the Dean of the school concerned".

The DRC members discussed the matter in the light of MANUU Ph.D Regulation and recommended for cancellation of Ph.D Admission of the above Scholars.

Item No.5. Exemption of Ph.D course work



As per MANUU Ph.D Regulations clause:-

- 5.15 A candidate shall be permitted to change his/her status from full-time to parttime researcher for a valid reason which shall be approved by the Vice Chancellor on the recommendation of Departmental Research Committee. In such cases the minimum and maximum duration shall be applicable to part-time Ph.D.
- 5.18 A full time research Scholar shall not accept any employment during the tenure of the Ph.D program.

9. De-Registration

- The research scholar shall be required to re-register within a period of two and half years failing which his /her admission stands cancelled.
- 9.3 The Ph.D thesis shall be submitted in such duration that the span of initial registration and re-registration done not exceed the total span stipulated for Ph.D program.
- The period of de-registration shall not counted for calculating the minimum 9.4 duration of Ph.D program.De-registration shall be allowed only once in the entire duration of Ph.D program.

The DRC members discussed the matter in the light of MANUU Ph.D Regulations and resolved that their request can not been considered

Item No.7. Request for converting regular Ph.D into Part-Time

An application has been received from Mr. Md. Faiyaz Equbal, Enrolment No.A180922, Research Scholar at CTE-Bhopal. He has been selected as Basic Grade General Teacher at Primary School Hakimabad, Bihar. He has joined the service w.e.f.03.03.2020. He has de-register his Ph.D on 03.03.2022. Now, he has requested to convert his Ph.D into Part-Time.

The DRC members discussed the matter in the light of MANUU Ph.D Regulations and resolved that there is no provision of conversion of full-time Ph.D into part-time. Further, a de-registered Research Scholar has to re-register the Ph.D programme.
