Ref: 1. MANUU Orders for constitution of 'COVID-19 Pandemic Monitoring Task Force & Committee for Re-opening of University in a Phased Manner dated 15.09.2021 2. The Minutes of the Eleventh & Twelfth Meeting of the Committee held on 22.12.2021 &

03.01.2022 and approval of the Competent Authority dated 24.12.2021 & 03.01.2022 respectively.

It is to notify that, in view of notifications issued on 31.08.2021 and 01.01.2022 by the Govt. of Telangana, and in view of fast spread of the new Covid variant 'Omicron', the "COVID-19 Pandemic Monitoring Task Force & Committee for Re-opening of University in Phased Manner" recommended the following:

- 1. It is strictly advised to follow the Covid Appropriate Behaviour (CAB); mandatory wearing of face masks, physical distancing, use of hand sanitizers, avoiding mass gathering etc. by all the stakeholders (i.e. students, staff and working members of the university). Screening at the entry points with IR thermometers/ thermal scanners is to be strictly followed.
- 2. The Heads of Departments are requested to obtain vaccination details of all students and send to office of the DSW by 07:01.2022.
- 3. The students who have visited their hometown for winter vacation should submit negative report of RTPCR upon arrival at hostels, similarly non-boarders shall submit the same in their respective departments.

4. The classes for the First Semester Students will continue in Online mode only until further orders.

5. With regard to MANUU Off-campuses (Satellite Campuses / CTEs / Polytechnics /ITIs/ Model Schools), the Principal/In-charge of the respective Off-Campuses shall follow the respective state/UTs orders/guidelines in respect to Covid pandemic.

COVID-19 – Disaster Management Act, 2005 – Measures to control spread of COVID in view of emergence of Omicron Variant of Concern – Enforcement till 10th January 2022 – Orders – Issued

ORDER:

In reference 4th read above, certain measures were put in place to control the spread of COVID-19 due to the emergence of Omicron Variant of Concern (VoC) in different parts of the country.

The situation has been further reviewed. Considering the reported increase in COVID-19 cases in certain states of the country, it is decided to impose the following further precautionary measures to control the spread of the disease.

3. The following activities shall be strictly prohibited throughout the state:

- i, Rallies
- ii. Public meetings
- Mass gatherings of all types including religious, political and cultural events

 Managements of public transport, shops, malls, establishments, offices, etc. shall ensure strict compliance with the following:

- i. Mandatory wearing of face masks
- ii. Physical distancing
- iii. Frequent sanitisation of premises

- iv. Provision for hand hygiene
- v. Screening at entry points with IR thermometers/thermal scanners

 Managements of schools and educational institutions shall ensure that all staff and students wear masks and follow COVID appropriate behaviour.

6. The orders for imposition of fine of Rs. 1,000 for not wearing of mask by people in public spaces issued in reference 1 read above shall be strictly enforced.

7. All persons should adhere to COVID appropriate behaviour, viz., wearing of masks in public places, maintaining physical distance, hand hygiene, etc.

8. Senior citizens and persons with comorbidities are specifically advised to exercise precautions against COVID-19.

9. The above orders shall come into force with immediate effect and continue to remain in force till 10th January 2022.

10. In exercise of powers conferred under the Disaster Management Act 2005, the undersigned, in his capacity as Chairperson, State Executive Committee hereby issues directions to all Collectors and District Magistrates, Commissioners/Superintendents of Police to strictly implement the above measures.
