**Sub: Advisory for Covid Appropriate Behaviour (CAB)-Notification Issued**

**2. The Minutes of the Nineteen Meeting of the Committee held on 27.04.2022 and approval of the Competent Authority dated 10.05.2022 respectively.**

It is to notify that, in view of increases cases of Covid 19 new variant in Delhi and few other states and in view of the summer vacations scheduled from 30.04.2022 to 18.05.2022 the "COVID-19 Pandemic Monitoring Task Force & Committee for Re-opening of University in Phased Manner" recommended the following:

1. All the MANUU Staff and students who would be travelling to various cities/states during the summer vacations are advised to adhere to Covid Appropriate Behavior at all times. They are further advised to wear masks especially during large gatherings/public transport etc., The Committee also advised all the MANUU stakeholders to get vaccinated as per the schedule/due.
2. All the MANUU Staff and students who travelled during Summer Vacations are not permitted to attend any large gatherings/functions at least for 10 days after reopening of the University i.e. till the end of the May 2022.
3. The Heads of the respective Departments/Provost (Boys & Girls)/ Sections Heads are advised that if any students/staff noticed with high fever/cough/sour throat (i.e. common Covid 19 symptoms), all such cases shall immediately be referred to the University Health Centre.
4. All the Principal/In-charge MANUU Off-Campuses (Satellite Campuses/CTEs/Polytechnics/ITIs/Model Schools) shall also follow this notification. However, they have to follow the guidelines issued by the respective state governments in this regard and intimate the same to the chairman.
