The Ministry of Education has brought to the notice of all the Central Universities that the ministry of environment, forest and climate change has framed *the comprehensive action plan for elimination of identified single use plastics and implementation of plastic management rules 2016*.

The guidelines for Elimination of single use of plastic and addressing the environmental concerns for government offices are as under:

- i. All Govt. Offices/Sub-ordinate offices etc. all other offices under the administrative control shall be declared single use plastic free by banning single use plastic items/disposable plastic items including:
- ii. a. All type of plastic carry bags and;
b. Plastic/thermocool (polyterene) disposable cutlery including cups/glass,bowls, forks, spoons, containers,straws etc. used for serving eatables/drinks.
- iii. Further, all Govt. Offices/subordinate offices etc. and all other offices' under the administrative control shall discourage to use plastic products including:
 - c. Artificial flowers, banners, flags, flower pots;
 - d. PET plastic water bottles
 - e. Plastic folders, trays etc.
 - f. Any other plastic material for which an alternative exists
 - g. All Govt. offices/sub-ordinate offices etc. shall promote and practice source segregation.

Hence all the stakeholders of MANUU at Headquarters and off-campus are requested to make concerted efforts to reduce plastic pollution by strictly adhering to the above guidelines. The Estate Section may design and action plan for elimination of single use plastic items in the University Campus.
