**Sub: Re-opening of University in Phased Manner-Phases IV & V-Notification Issued**



It is to notify that, in view of notification dated. 31.08.2021 by the Govt. of Telangana, the "COVID-19 Pandemic Monitoring Task Force & Committee for Re-opening of University in Phased Manner" recommended re-opening of the University for the following students:

Phase	Category/year of Students (Headquarters and off-Campuses)	Re-opening	Commencement of Offline Classes
Phase-IV	B.Tech-2 <sup>nd</sup> Year Diploma- 2 <sup>nd</sup> year B.Voc-2 <sup>nd</sup> Semester	22.11.2021	Online classes will be continued till 29.11.2021, and from 30.11.2021, only offline classes will be conducted
Phase-V	All Newly admitted students (UG, PG, Diploma programmes)	1.12.2021	Online classes will be continued till 6.12.2021, and from 7.12.2021, only offline classes will be conducted.

1. The abovementioned students are allowed to return in Phases-4 and 5 and further they shall submit an undertaking. It is mandatory for the students to get administered with at least one dose of COVID-19 vaccination before arriving to the University.
2. Hostel Boarders shall submit the undertaking at the concerned Provost Office, whereas Non boarders shall submit the undertaking at the office of concerned Head of the Department.
3. With regard to other MANUU Off-campuses (Satellite Campuses / CTEs / Polytechnics /ITIs/ Model Schools), the Principal/In-charge of the respective Off-Campuses shall obtain the permission from the central committee for opening of any Off-Campuses of MANUU. However they may close the institute anytime as warranted by the local government rules.
