

DRC Meeting

Minutes of the Meeting held on 30.08.2017 at 11.00 AM

The Al-Beruni Centre for the Study of Social Exclusion and Inclusive Policy held a Departmental Research Committee (DRC) on 30 August, 2017 at Director's room. The committee reviewed the status of research work of all PhD research scholars enrolled in the Centre. The following decisions were made after a thorough examination of every scholar's progress, regularity and so on.

- 1. The committee was convinced that Arfat Fatima may be given one year extension as she had pregnancy, child birth with a cesarean operation and the post delivery problems. She was asked to submit all the necessary documents in this regard.
- 2. Ayesha Tarique has also done 2/3 of her work and needs 6 months extension as also she had gone through the process of pregnancy and child birth. She was asked to submit all the necessary documents in this regard.
- 3. Mohammad Abdul Moid and Iqbal Ahmed have completed 6 years. They have not sought official extension with valid reasons. However, they have shown work in almost completed form. They can submit their thesis if the University allows.
- 4. Both Md. Owais Amanullah and Asif Eqbal Ansari did not appear before the DRC. It is decided that the letter must be sent to them with possible termination of their admission, if they do not report in the Centre by 30 September, 2017.
- It is also decided that Tabrez Hussain has shown good progress after completion of four years. In view of his supervisor's (Prof.Kancha Ilaiah) retirement, Dr.A.Nageswara Rao, Assistant Professor, ACSSEIP, should be assigned as a co-supervisor.
- 6. The DRC felt that the progress of other research scholars, viz., Musheera Fatima, Md. Nazrul Hoda, Imteyaz Ahmad, Firoz Alam, Asma Anjum, Mushtaque Ali, Mohd Usman and S.M. Abbas Hussain Naqvi, is found satisfactory.

The Al-Beruni Centre for the Study of Social Exclusion and Inclusive Policy held a meeting of Departmental Research Committee (DRC) on 01.11.2017 at 3.00 PM at Director's room. The Committee reviewed the status of research work of PhD students Mr. Firoz Alam (2013-14) and Mr. Mohammad Abbas Hussain Naqvi (2014-15). The following decisions were made after a thorough examination of the research progress of these two research scholars.

- 1. Research Advisory Committee Report of Mr.Firoz Alam and Mr. Mohammad Abbas Hussain Naqvi Ph.D students at ACSSEIP were discussed at the DRC meeting. The Progress of their research was found satisfactory by the DRC. It has been resolved that they may be given Non-Net Fellowship for further remaining period.
- 2. The continuous absence of Md Owais Amanullah and Asif Eqbal Ansari was again discussed by the DRC. The Supervisors of both the students have expressed their dissatisfaction on their research progress as they did not turn out to them for long. The Centre has already sent letters and E-mail notice for their absence but no response has been received as yet. After due deliberations, DRC has recommended that these students may be given the last chance till 15th November, 2017 to turn up to the Centre and report to their supervisors. The DRC further resolved that Director I/c may write a letter to the concerned university authorities for cancellation of their admission if they do not turn up by the 15th November, 2017.
- 3. In addition to the existing list of eligible supervisors of the Centre, Dr.K.M.Ziyauddin has been approved by the DRC to guide M.Phil and PhD Research Students from the Academic

The Director (I/C) welcomed all the members and commenced the proceedings after ascertaining the Quorum for the meeting. Following agenda items have been discussed in the meeting.


AGENDA - 1: To consider the extension of Ms. Ayesha Tarique's Ph.D. submission date.

RESOLUTION -1: The Director (I/c) has brought before the DRC all the related issues of Ms. Ayesha Tarique that are as follows:

- Ms. Ayesha Tarique, Ph.D. Student of ACSSEIP working under the supervision of Prof. Farida Siddiqui has completed **five** years on 22 August, 2016.
- She made a request for extension on 22 August, 2016 as she failed to complete her work due to medical reasons i.e. pregnancy. As per the document, the date of delivery is 20th July, 2016. The Research Committee Meeting held 1st September, 2016 has recommended for her extension and processed the file to Dean, School of Arts & Social Sciences.
- The Dean has asked for clarification and discussion. But somehow the matter was not pursued after that with Dean. As a result, extension for sixth month was not done. During these periods, Ms. Ayesha Tarique did not visit the Centre.
- On 16th August, 2017, Ms. Ayesha Tarique submitted another letter forwarded by her Supervisor seeking seventh-year extension assuming that her sixth-year extension was done. The extension was again sought on maternity and child care ground.

The Al-Beruni Centre for the Study of Social Exclusion and Inclusive Policy held a Departmental Research Committee (DRC) on 13 December, 2018 at Director's room. The committee reviewed the status of research work of all PhD research scholars enrolled in the Centre. The following decisions were made after a thorough examination of every scholar's progress, regularity and so on.

- 1. Mr. Mohammad Abdul Moid has completed 7 years and has requested in the month of May, 2018 to the Hon'ble Vice Chancellor for the approval to submit his PhD thesis. The Academic Section-MANUU has sought the opinion of the DRC in this regard. DRC has seen the draft copy of his thesis and is satisfied with the work, which is ready for submission. The student has cited Telangana State agitation as the main reason for delay and the consequent disturbances caused during his fieldwork. As his topic demanded to study the role of Muslims in Telangana politics and their political participation in the state that required serious fieldwork. It took more than a year to record the events to bring out a quality PhD thesis. which caused delay in the submission of the thesis and this was beyond the control. Moreover, his recurrent personal illnesses and also health issues of his family members also caused the delay and DRC looked this sympathetically. However, as he took more than 7 years, only the Hon'ble Vice Chancellor has the power to permit him for submission. The DRC recommends that the thesis may be submitted if Hon'ble VC permits him as a special case.
- 2. The research progress of Mr. S.M. Abbas Hussain Naqvi, (PhD. Student- 2013-2014) was discussed in DRC. The Proctor Office had earlier communicated to the Centre that student related services to him be stopped. Moreover, Dr. A. Nageswara Rao, Research Supervisor of Mr. Naqvi, informed that the scholar is not serious about his research and is not reporting to him for the last 7 months. The DRC resolved that the necessary action may be initiated against his continuous absence as reported by the research supervisor.
- 3. The DRC felt that the progress of other research scholars, viz., Mr. Tabrez Hussain, Ms. Asma Anjum, Mr. Mushtaque Ali and Mr. Mohd Usman is found satisfactory.
- 4. The DRC resolved that the Pre-Submission of Ms. Asma Anjum, (PhD. Student- 2013-2014) and Mr. Tabrez Hussain, (PhD. Student- 2013-2014) should be conducted on or before 31st December 2018.


