Minutes of 6<sup>th</sup> BOS Meeting [1.2.1] ⇒ (Annexure 01)  
held on 30<sup>th</sup> September 2016

The 6<sup>th</sup> Board of Studies meeting of the Department of Islamic Studies held on 30<sup>th</sup> September 2016 in the office of the Department of Islamic Studies at 10:30 AM.

At the outset, the chairman of the BOS welcomed all Members in the new building of the Department of Islamic Studies in the school of Arts and Social Sciences building. After that, the BOS members discussed the agenda items and resolved the followings:

**Item No. 1: Approval of minutes of 5<sup>th</sup> BOS meeting**

Since the minutes of the 5<sup>th</sup> BOS meeting held on 18<sup>th</sup> February 2016 were distributed among the Members and no comment has been received, the BOS approved the minutes of the 5<sup>th</sup> BOS meeting.

**Item No. 2: Minor changes in the syllabus of P.G and U.G programs**

The chairman of the BOS brought to the notice of the Members that, the P.G and U.G syllabus of the Department of Islamic Studies was finalised and approved by the 5<sup>th</sup> BOS meeting held on 18<sup>th</sup> February 2016 and subsequently got approved in 24<sup>th</sup> Academic Council held on 28<sup>th</sup> march 2016.

As per the decision of 24<sup>th</sup> Academic Council meeting, the Department was asked to prepare a common syllabus of Islamic Studies both for Regular as well as Distance mode programs, both for P.G and U.G courses. Acting upon this decision, the Department made some minor changes in the approved syllabus and prepared a common syllabus for Regular

and Distance mode programs. The content of this common syllabus of UG and PG is the same as approved by the 5<sup>th</sup> BOS meeting and 24<sup>th</sup> Academic Council meeting. Only changes have been made in the shifting of some papers from one semester to another semester, to make it suitable for the format of yearly syllabus of Distance mode program.

Following shifting of the papers has been done:

**In PG syllabus:**

- Paper No MIS 401 has been shifted as MIS 103
- Paper No MIS 103 has been shifted as MIS 204
- Paper No MIS 204 has been shifted as MIS 301
- Paper No MIS 301 has been shifted as MIS 401

**In UG syllabus:**

- Paper No BIS 301 has been shifted as BIS 201
- Paper No BIS 201 has been shifted as BIS 301

Since these changes in the P.G and U.G syllabus have been approved by Honourable Vice Chancellor, the BOS ratified the same.

**Item No. 3: Discipline Specific Elective (DSE) and Generic Elective (GE) papers**

As per the guidelines of UGC and MANUU for the implementation of CBCS system in PG program, the Department has designated one paper each in 1<sup>st</sup> and 2<sup>nd</sup> semesters, two papers in 3<sup>rd</sup> semester and three papers in 4<sup>th</sup> semester as *Discipline Specific Elective (DSE)* papers. One separate paper with the title of "Fundamentals of Islamic Studies" is offered as *Generic Elective (GE)* paper in 2<sup>nd</sup> semester.

The BOS discussed the item and approved.

**Item No. 4: Common syllabus for Regular and Distance mode programs for UG and PG**

The BOS discussed the common syllabus of Regular and Distance mode programs of Islamic Studies for UG and PG programs. Since the Regular program has semester system with two semesters in one year, while the Distance mode program has early format, the papers of two semesters of regular mode have been merged as one year papers of Distance program in each year. And in PG program, only one DSE Paper has been included in distance mode syllabus.

The BOS discussed the common syllabus of P.G and UG programs for Regular and Distance mode programs and approved.

**Item No. 5: Eligibility criteria for Diploma in Islamic Studies program**

The BOS discussed this item and resolved that the eligibility criteria for admission into *Diploma in Islamic Studies* program would be any 10<sup>th</sup> or equivalent degree. There will be no age bar for this program. And this will be a part time program, having two papers with three periods of each paper per week. The intake will be 30, and any MANUU student or others with the said eligibility criteria can take admission in this program.

**Item No. 6: Allied subjects of Islamic Studies**

The BOS discussed this item and resolved that only for the purpose of admission in M. Phil/Ph.D program in Islamic Studies, the subject of **Arab Culture** would be considered as allied subject. However, the preference in admission will be given to those having PG in Islamic Studies degree.

**Item No. 7: List of Refereed/Reputed Journals in the subject of Islamic Studies**

A list of Refereed/Reputed journals in the subject of Islamic Studies in English, Arabic and Urdu languages has been presented in the meeting.

The BOS discussed this item and resolved that the Journals mentioned in the list would be considered as refereed/reputed Journals in the subject of Islamic Studies. The BOS also resolved that 'All journals published by any Central/State University in India' would be considered as refereed/reputed Journals. The BOS authorised the chairman to make addition in this list as and when needed.

**Item No. 8: list of Madarasas for recognition of Degrees**

A list of Reputed Madarasas from across the different states of the country is presented in the meeting for the purpose of considering their degrees of FAZEELAT/ALMIYAT as equivalent for admission into MA in Islamic Studies program.

The BOS discussed this item and approved the list for the purpose mentioned above.

**Item No 9. Any other matter**

Under this item the BOS discussed and resolved the followings:

- **Revised Syllabus of Compulsory Islmiyat paper**

The Department prepared the syllabus of compulsory Islamiyat paper for two semesters for all UG programs of MANUU, as per the approval of the 24<sup>th</sup> Academic Council meeting, and got this syllabus approved by Honourable Vice Chancellor of MANUU. Since this paper has only two credits, the Department further revised/reduced the syllabus, and presented it in this BOS meeting for ratification and approval.

The BOS discussed the item and approved.

- **Journal of Islami Mutala'at**

The BOS appreciated the efforts of the Department in bringing the first issue of yearly 'Journal of Islami Mutala'at' (*Majalla Islami Mutala'at*) by its Research Scholars, and with recommending to continue it, asked the Department to try to make this journal a Research Journal of International standard in the subject of Islamic Studies, and outline its objectives and other administrative details to present the matter in the next BOS meeting.

- **Subject Association**

The BOS discussed the need of Subject Association, and appreciated the presence of Subject Association in the Department. To engage this Association in different kinds of academic and cultural activities in the Department, the BOS suggested that some fee could be collected from the students at the time of admission, to utilise this amount in meeting the expenses of activities of Subject Association.
