After that, the agenda items were taken for discussion and resolution.

**Item No. 1: Approval of Minutes of 7<sup>th</sup> BOS Meeting:**

The Minutes of 7<sup>th</sup> BOS Meeting held on 8<sup>th</sup> February 2017 were circulated among the members. Since no comment has been received, the BOS approved the Minutes of 7<sup>th</sup> BOS Meeting.

**Item No. 2: Approval of the syllabus of M.Phil/Ph.D course Work:**

The syllabus of M.Phil/Ph.D course Work as per new CBCS system was prepared along with options in 3<sup>rd</sup> paper. The Board of Studies discussed this syllabus and approved.

**Item No. 3: Approval of Changes in M.A Islamic Studies syllabus:**

In the syllabus of MA Islamic Studies, the paper 2<sup>nd</sup> and 3<sup>rd</sup> of first sem have been merged and made as paper 2<sup>nd</sup> named "Fiqh Aur Tasawwuf" and one paper titled "Islam Aur Jadid Masael" from options of fourth

sem papers, has been moved in first sem and made 3<sup>rd</sup> paper in this first sem. Accordingly in fourth sem, the allotted codes to option papers have been corrected. The BOS discussed this item and approved.

**Item No. 4: Approval of new codes allotted to all papers in all courses of PhD, PG, UG and Diploma:**

As per the MANUU guidelines, all papers in all courses of PhD, PG, UG and Diploma have been allotted codes. The BOS discussed this item and approved.

**Item No. 5: Approval of the Panel of Examiners for all courses:**

A list of Panel of Examiners for all courses of PhD/MPhil, PG, UG and Diploma, as per the MANUU format prepared and presented in the meeting. The BOS discussed this item and approved.


**Item No.6: Any other matter with the permission of Chair:**

**a) Approval of Changes in UG, Islmiyat and IMWR Syllabus.**

As per the MANUU guideline and CBCS system, the UG syllabus of Islamic Studies has been framed as per six units in each paper. There is no change in the content of this syllabus. The syllabus of "Islamiyat" and the Syllabus of "Introduction to Major World Religions" have also been made as per Two units in each paper to make them according to Two credits. In these two syllabus some reduction in the content and modification have been made. The BOS discussed this item and approved.

**b) Approval of Panel of Evaluators for research thesis.**
