Sub: Establishment of University Industrial Training Institutes at Hyderabad, Bangalore and Darbhanga, reg.,

The objectives of the University as per the Act is to promote and develop Urdu language; in impart education and training in vocational and technical subjects through the medium of Urdu; to provide wider access to people desirous of pursuing programmes of higher education and training in Urdu medium through teaching on the Campus as well as at a distance and to provide focus on women education.

The studies conducted by various agencies, indicate that a large number of Urdu learners diagontinue their studies early in life because the social condition does not allow them to invest time and money in an activity that is long-term and has no assured economic returns. To bring these people in the social mainstream and equip them with skills to earn a livelihood, Vocational training is identified as better option, thus fulfilling the objectives of the University. Thus, the University has been permitted to start the following courses by the UGC:

Hyderabad (at Headquarters) center:

- 1. Certificate course in Electronics mechanic (2-years)
- 2. Certificate course in Air conditioning and Refrigeration Mechanics (2-years)
- 3. Certificate course in Plumbing (1-year)
- 4. Certificate course in Electrician (2-years)
- 5. Certificate course in Draughtsman Civil (2 years)

Hangalore center:

- Certificate course in Electrician
- Certificate course in Air conditioning and Refrigeration Mechanics

Darbhanga center:

- Certificate course in Electrician
- 2. Certificate course in Plumbing

Sub: Starting of the courses in Industrial Training Institutes, rules and regulations for admissions, syllabi, Scheme of Examinations, with effect from the Academic year 2006-07

Admission procedure:

The academic qualification prescribed for the trade varies from class VIII pass to Class X pass depending upon the trade.

S. No	Trade	Qualifications	Duration
1	Plumbing	8 th Class with Urdu knowledge	1-year
2	Electronics Mechanic	10 th Pass with Urdu knowledge	2-year
3	Electrician	10 th Pass with Urdu knowledge	2-year
4	Refrigeration and Air- Conditioning mechanic	10 th Pass with Urdu knowledge	2-year
5	Draughtsman Civil	10 th Pass with Urdu knowledge	2-year

As per the recommendation of NCVT admission in ITI s are to be made purely on merit based on the marks secured by the candidate in the public examination of the minimum qualification prescribed for the individual trade.

Age, age relaxation, Qualifications & Durations:

The candidates of 14 - 40 years of age as on date of start of admission session are eligible for admission in ITI

- (I) Upper age limit up to 45 years in case of ex-servicemen.
- (ii) Relaxation of upper age limit up to 45 years permissible in case of war widows.

Reservation of seats: This should be as follows:

- (i) 15 % SC, 7.5% ST, 3% PH, 1% Kashmiri migrants, 1% NSS/Sports/Exserviceman; in case of non-availability of candidates, seats may be filled with general candidates.
- (ii) 25% seats will be reserved for women candidates and these seats can be filled up based on the general reservation policy of each State/UT, the total reservation being limited to 50%. If the seats meant for them are not utilised fully, the same can be filled in by men candidates subsequently.

For boys and girls sponsored by the recognized orphanages, if specific reservation is not possible at least preference should be given to them at the time of admission to the Industrial Training Institutes/Centres.

Last date for submitting application forms: 18th July 2006

Last date for admissions: 31st July 2006

Closure of admissions: 31st August 2006 for 2 – years trade and 14th August 06 for one year trade.

Commencement of classes: 1st August 2006

FEE:

The University shall not charge any fee except caution money of Rs. 60/- per student at the time admission. University may sanction a stipend of Rs. 100/- per candidate per month from the provision of non-plan grant.

4. SYLLABI:

The University shall follow the syllabi prescribed by Director General Employment & Training, GOI, Ministry of Labour, New Delhi for ITIs and ITCs.. The details of syllabi of each trade is appended.

EXAMINATIONS:

The DGE & T, New Delhi conducts examinations annually at the end of the course, the pattern is being followed by all the ITI s & ITC s all over country. The University shall also follow same procedure in order to keep University courses recognized by DG E &T for amployment. The certificates of the respective trades will be issued by the DG E & T, New Delhi man par with the other Institutes of the country.
