The following Act of Parliament received the assent of the President on the 8th January, 1997 and hereby published for general information:---

THE MAULANA AZAD NATIONAL URDU UNIVERSITY AC

No. 2 of 1997

[8th January, 1997.]

An Act to establish and incorporate a University at the national level mainly to promote and develop Urdu language and to impart vocational and technical education in Urdu medium through conventional teaching and distance education system and to provide for matters connected therewith or incidental thereto.

Be it enacted by Parliament in the Forty-seventh Year of the Republic of India as follows:-

1. (1) This Act may be called the Maulana Azad National Urdu University Act,

(2) It shall come into force on such date as the Central Government may, by vilication in the Official Gazette, appoint.

2. In this Act, and the Statutes made hereunder, unless the context otherwise

(a) "Academic Council" means the Academic Council of the University;

In view of the above, recommendation of the Standing Committee, the Registrar, Maulana Azad National Urdu University, Hyderabad is hereby permitted to take admissions in the above trades for the admission session 2007-2008 with the condition that the trainees admitted on the recommendation of the Standing Committee will be allowed to appear for All India Trade Test examination only after the receipt of the affiliation order from the DGE&T, failing which they will be trade tested in SCVT examination. The conditions should be appraised the above condition and should take an undertaking accordingly.

Further, the Registrar is permitted to issue notification in the news papers for admissions into ITI courses in Urdu Medium.

DRAFT ORDINANCE

ESTABLISHMENT OF VOCATIONAL TRAINING CENTRES (INDISTRIAL TRAINING INSTITUTES) [Act, S. 27(k)]

In exercise of the powers vested under the Section 27(k) of the University Act, 1996 (No.2 of 1997) this ordinance is issued for the establishment of Vocational Training Centers/ Industrial Training Institutes.

Commencement: From date of notification by the University

Purpose of Ordinance:

The purpose of the Ordinance is to establish Vocational Training Centres! Industrial Training Institute to offer vocational courses aimed at providing training programmes in professional trades in Urdu medium. The trades with job potential and / or self-employability shall be offered. The institute shall be fully funded by the UGC / Govt. of India. Initially these institutes shall be establish at Hyderabad, Dharbhanga and Bangalore; and in and other places, with the approval of the University Grants Commission.

The objectives of the Institute:

- * To provide training in trades which have job potential.
- * To help and guide the students in providing employment after completion of the training.

Duration of the Training Programme: The duration of the Training programmes, shall be as per National Council for Vocational Training (NCVT), Government of India norms.

Fee: No admission and tuition fee shall be charged. Caution money of Rs. 60/- per student shall be charged at the time of admissions.

Qualifications and admissions: The academic qualification prescribed for the trade varies from class VIII pass to Class XII pass depending upon the trades as per National Council for Vocational Training (NCVT) norms.

Age: The candidates of 14 - 40 years of age as on date of start of admission session are eligible for admission in these Institutes / Centers.

Age relaxation:

Relaxation of upper age limit upto. 45 years in case of ex-servicemen is ii.

Relaxation of upper age limit upto 45 years permissible in case of war widows. iii.

Widows / separated women would be allowed to join various training programmes under C.T.S up to the age of 45 years. iv.

The upper age limit of physically handicapped candidates has been relaxed by 10 years and kept as 45 years on the date of start of admission session.

Reservation of seats: As per the National Council of Vocational Training (NCVT)

Admission procedure: As per the norms of National Council of Vocational Training admission in ITI are to be made purely on merit based on the marks secured by the candidate in the public examination of the minimum qualification prescribed for the individual trade. Where ever there is no public examination at the minimum qualification level the merit may be made on the marks obtained by the candidate in the written examination conducted by the University.

Selection of candidates for admission in Industrial Training / Centers start well in advance of the commencement of each session. Admissions should be as far as possible, be completed by the date of starting of the session. Where it may be necessary to continue admission beyond the date of commencement of the session for filling vacant . seats, it should not in any case go beyond one month of the date in the case of two-year trades and 15 days in case of one-year trades.

Start of Session: Training sessions in ITIs /VTCs may start from 1st August every year.

Syllabi: As per National Council for Vocational Training norms.

Examination: National Council for Vocational Training shall conduct exams annually or at the end of the session in one year courses. Mark sheet and certificates shall be issued by National Council for Vocational Training.
