#### ORDER

WHEREAS, College of Teacher Education, MANUU, Kamran Millat High School Complex, Chandapatti, Darbhanga, Bihar-846001 was granted recognition for B.Ed. course with an intake of 100 vide ERC order No. ERC/7-74.7(1) 12/2007/6804 dated 05.03.2007, followed by revised recognition order from the academic session 2015-2016 with an intake of 100 (two basic units) vide dated 31.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 263th meeting held on 15th 16th November, 2018 considered the matter and Show Cause Notice w/s 17(1) was issued on 27.11.2018 to the institution on the following grounds:
  - (i) Faculty list duly approved by the concerned affiliating body not submitted.
  - (ii) Building completion certificate is not signed by Govt. Engineer.
  - (iii) Photocopy of building plan is in small font and not legible. The institution is required to submit clear copy of building plan duly approved by Govt. Engineer.
- 3. AND WHEREAS, the institution has submitted reply dt. 28.11.2018 on the basis of minutes uploaded in ERC Website. The ERC in its 268th Meeting held on 24th -25th February, 2019 considered the matter show cause notice u/s 17(1) was issued on 13.03.2019 on the following grounds:-
  - (i) Submitted faculty list comprising only 1+6 faculties instead of 1+15 and not approved by the concerned affiliating body.
- 4. AND WHEREAS, the institution has submitted reply dt. 20:03.2019 in response to show cause notice issued by ERC letter dated 13.03.2019. The ERC in its 271st meeting held on 24th -25th April, 2019 after considering the matter and final show cause notice u/s 17(1) was issued on 14.05.2019 on the following grounds:-
  - (i) The institution has not submitted list of faculty comprises 1 (Principal) + 15(lecturers) duly approved by affiliating body as required under NCTE Regulations, 2014.
- 5. AND WHEREAS, the institution has not submitted reply in response to show cause notice issued by ERC letter dated 14.05.2019. The ERC in its 278<sup>th</sup> meeting held on 16<sup>th</sup> -18<sup>th</sup> January, 2020 after considering the matter and observed that the institution is still deficient on the following grounds:
  - (i) Approved list of teaching faculty is not duly approved by the affiliating body.

- 6. NOW THEREFORE, recognition granted to the institution viz. College of Teacher Education, MANUU, Kamran Millat High School Complex, Chandapatti, Darbhanga, Bihar-846001 (APE00698) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.
- 7. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website <a href="www.ncte-india.org">www.ncte-india.org</a> within 60 days from the date of the issue of the order.
