ORDER

WHEREAS, Maulana Azad National Urdu University, Plot No.-2, Khasra No.-1851, Chandanpatti, Tehsil/Taluka- Bahadurpura, Town/City- Darbhanga, Darbhanga, Bihar-846001 (Code No. ERCAPP2046) was granted recognition for M.Ed. course with an intake of 35 from the academic session 2014-2015 vide ERC order No. 23974 dated 19.02.2014, followed by revised order vide No.32523 dated 30.05.2015 with an intake of 50 (one basic unit) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 267th meeting held on 10th 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the 2. institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - competent concerned the b. Approved building plan Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
 - AND WHEREAS, the institution has submitted reply vide letter dt. 25.03.2019 received on 28.03.2019. The ERC in its 271st Meeting held on 24th - 25th April, 2019considered the matter and another Show Cause Notice u/s 17(1) was issued in 18.05.2019 to the institution on the following grounds:-
 - In the submitted approved list, part-time/guest faculty is not accepted.

Building plan is not approved by competent Govt. Engineer.

(iii) Building completion certificate is not signed by competent Govt. Engineer.

(iv) Website not maintained and updated.

AND WHEREAS, the ERC in its 272nd Meeting held on 30th – 31st May & 1st June, 2019 considered the reply dt. 13.05.2019 (on the basis of proceeding uploaded on ERC website) received on 28.05.2019 and decided that the institution has fulfilled all criteria as per NCTE Regulations, 2014 in compliance to revised recognition order. - 5. **AND WHEREAS,** the decision of ERC was not communicated to the institution and the matter was re-considered by ERC in its 274^{th} meeting held on 15^{th} 16^{th} July, 2019 under the Agenda item No. 274.1.9 before confirmation of proceedings of 272^{hd} ERC meeting.
- 6. **AND WHEREAS**, the decision taken by ERC at sl. No.124, Item No.272.14.114 of proceedings of 272nd meeting is rectified by the Committee in its 274th meeting held on 15th -16th July, 2019. The institution is still deficient on the following grounds:
 - (i) 1st Show Cause Notice u/s 17(1) issued on 21.02.2019.
 - (ii) Final Show Cause Notice u/s 17(1) issued on 18.05.2019.
 - (iii) Institution requested for extension of time to comply the deficiencies mentioned in the SCN, which is not accepted by the Committee.
 - (iv) No new appointment of faculty made as per NCTE norms. Faculty list is not as per NCTE Regulations, 2014.

Recognition granted to M.Ed. course of the application bearing Code No.ERCAPP2046 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

- 7. **NOW THEREFORE**, recognition granted to the institution viz. Maulana Azad National Urdu University, Plot No.-2, Khasra No.-1851, PO.- Chandanpatti, Tehsil/Taluka-Bahadurpura, Town/City- Darbhanga, Dist.- Darbhanga, Bihar-846001 (Code No. ERCAPP2046) for M.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the 2020-2021.
- 8. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal. Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
