- 8. The Committee members discussed about the importance & need of the CWS in the University to fulfill the mandate of MANUU. The Committee members strongly felt that regular activities should be conducted by CWS within the University or in the Urdu Community for the awareness on Gender equality, women's rights and gender issues. Therefore committee recommends the permanency of the Centre in MANUU. Members requested the authority to give permanent position to CWS and to allocate annual budget to run the Centre and to conduct various activities for Gender Sensitization & Woman Empowerment.
